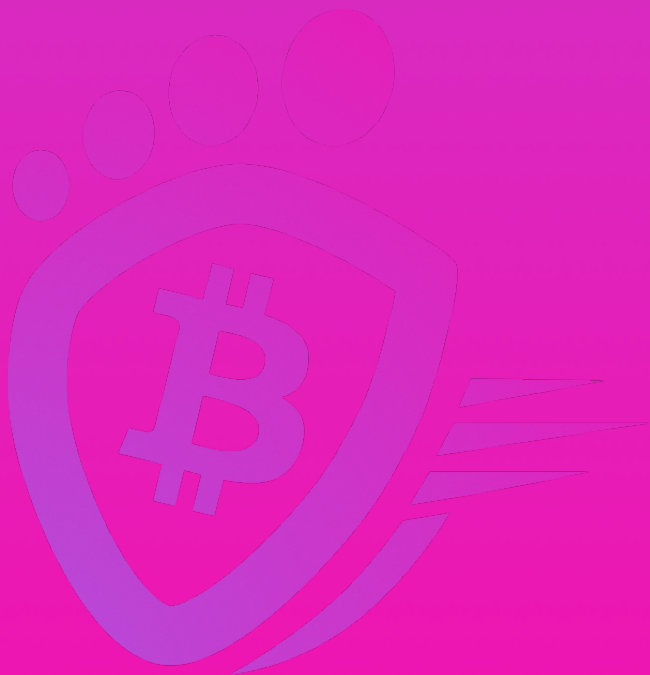
BabyCoin is a next-generation decentralized launchpad designed to democratize access to early-stage crypto opportunities. Built for inclusivity, security, and transparency, BabyCoin introduces a community-first model that empowers small investors with opportunities traditionally reserved for private funds and large institutions. Through a hybrid Launchpad mechanism, liquidity protections, audited smart contracts, and reputation-based allocation, BabyCoin aims to redefine the early-stage Web3 investment landscape.

1. Introduction

The Web3 ecosystem has witnessed rapid growth in the number of decentralized projects seeking funding. Despite this expansion, early-stage investment opportunities remain inaccessible to most users due to high barriers to entry, private sales dominated by institutions, and opaque project evaluation processes. BabyCoin addresses these challenges by providing a fair, secure, and transparent launchpad designed for both new and experienced crypto participants.

1. **Inclusivity** – Allowing micro-investments and granting access to high-potential projects.

3. **Community Governance** – Enabling token holders to shape listing decisions, allocations, and the platform's evolution.



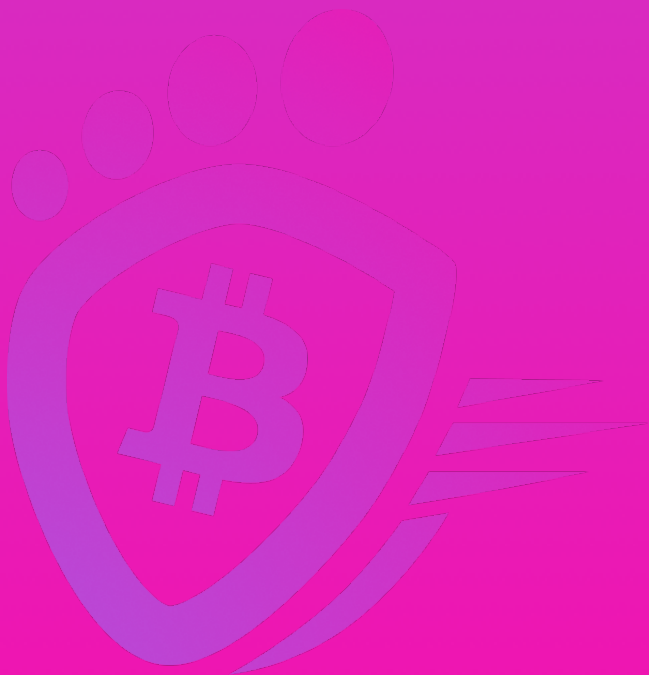
2. Vision & Mission

5. Tokenomics

The \$BBC token economy is engineered to create long-term growth, irresistible early-stage appeal, and a powerful cycle of recurring demand. Unlike typical launchpad tokens that rely on hype alone, \$BBC is fueled by real platform activity, real utility, and real multichain usage. As BabyCoin.io expands, \$BBC becomes increasingly essential—not optional—for both investors and creators.

At its core, \$BBC is the universal presale currency powering the entire BabyCoin ecosystem. Every presale, every launch, every tool, and every creator interaction flows through \$BBC, making it the heartbeat of a rapidly growing multichain launch economy.

5.1 Total Supply & Price Structure

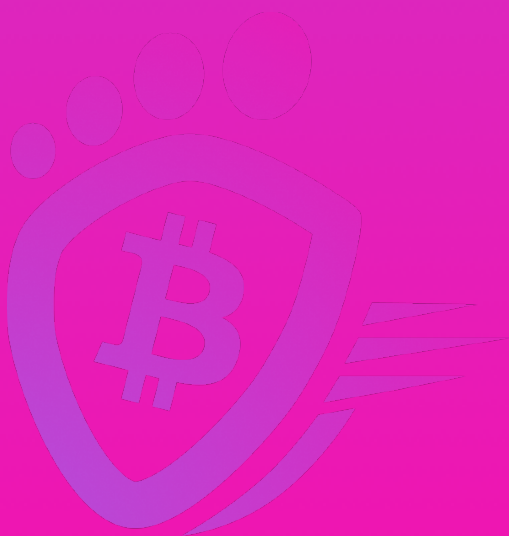
Total Supply: 10,000,000,000 \$BBC

Listing Price: \$0.003 per \$BBC

This supply and pricing model is intentionally designed to:

- Appeal to retail psychology with an accessible entry price.
- Enable liquidity across multiple blockchains.
- Create strong long-term scarcity as more projects launch.
- Allow investors to accumulate meaningful amounts early, fueling healthy FOMO.

With a low listing price and a high-utility ecosystem, \$BBC offers the perfect blend of affordability and future upside potential.



5.2 Initial Circulating Supply & Market Cap

To maximize early momentum and investor appeal, only a small percentage of the supply will be available at launch.

Initial Circulating Supply: ~2% (200,000,000 \$BBC)

Initial Market Cap: \$600,000

This creates a strategic balance:

- Low enough to generate excitement and strong upward pressure.
- High enough to signal stability and serious long-term potential.
- Attractive for both retail and strategic investors.

A lean initial market cap paired with high-utility demand creates ideal conditions for early-stage growth.



5.3 Token Distribution

The \$BBC distribution model ensures fairness, ecosystem longevity, and sustainable expansion:

- **Seed Round – 5% (500M \$BBC)**
For early believers aligned with long-term growth.
- **Private Round – 10% (1B \$BBC)**
Allocated to strategic partners who support global adoption.
- **Public IDO – 20% (2B \$BBC)**
Open to the community, giving everyday investors a real shot at early access.
- **Team & Advisors – 10% (1B \$BBC)**
Locked and vested to maintain long-term commitment and stability.
- **Ecosystem Development – 20% (2B \$BBC)**
Fuels future integrations, chain expansions, utilities, and platform upgrades.
- **Liquidity & Reserves – 20% (2B \$BBC)**
Ensures strong markets, stable trading, and multichain liquidity provisioning.
- **Community Rewards – 15% (1.5B \$BBC)**
Supports staking, loyalty, incentives, and long-term user retention.



5.4 Token Utility

\$BBC is not just a token—it is the currency of early-stage opportunity. Its utility is built into the core of the BabyCoin ecosystem:

1. Presale Participation

\$BBC is the **only token** investors can use to participate in presales on BabyCoin.io—across all chains. This is \$BBC's strongest value driver.

2. Project Launch Payments

Creators use \$BBC to:

- Create tokens
- Host presales
- Access BabyTools
- List on the ecosystem

Every new project directly increases \$\$BBC demand.

3. Staking & Allocation Boosts

Staking \$BBC unlocks higher tiers, early access slots, and allocation multipliers.

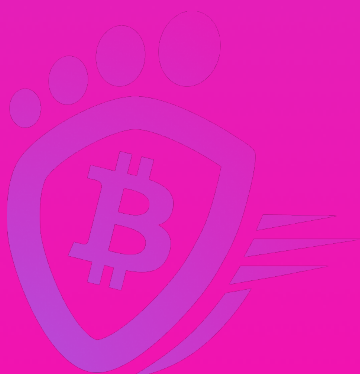
4. Governance

5.5 Vesting Model

Vesting ensures long-term trust and prevents harmful early sell-offs:

- **Seed & Private Rounds:** 10% at TGE, remaining vested over 6–12 months.
- **Team & Advisors:** 12-month cliff followed by 24 months of gradual vesting.
- **Ecosystem & Community Funds:** Released in phases aligned with growth milestones.

This creates a stable economic foundation where the platform—and the token—grow together.

5.6 Why you should invest in \$BBC

The \$BBC economy is designed around one simple truth: **every investor wants to be early.**
